

AFRICAN AMERICAN COMMUNITY FUND

WOMEN'S FUND

\$27,000

Activity highlight: On November 1, 2018 powerful women from across Northeast Ohio gathered for Leadercast Women Lorain County. A portion of the audience was youth, who had the opportunity to find mentors in the crowd. Participants had the opportunity to not only empower each other, but also network with individuals across the job sector.

Activity highlight: In October 2018, the Hispanic Fund hosted their Harvest Fiesta event where grantees were awarded funding as part of the Fund’s ongoing commitment to “improve and promote socioeconomic and educational opportunities within the Hispanic Community.”



THE YOUTH FUND





What is an endowment fund?

Imagine leaving a legacy during your lifetime that allows you and your family to witness the change in the community you care so passionately about. Community Foundation of Lorain County can help you get started.

Here's how it works

Donors simply make a permanent, tax-deductible donation to the Community Foundation of Lorain County or charity. The amount can vary and the principal is invested to provide ongoing, sustainable funding for causes or organizations. Because only a percentage of the investment earnings are distributed as grants or scholarships, an endowment fund allows you to give far more over time than the value of a one-time gift.

Here's what makes an endowment fund unique

An endowment fund can be personalized to fulfill any charitable goal and can be established now or at the time of passing. Funds can be created in your name or your family's name, in memory or honor of a loved one, or to benefit a specific cause or charity.

With more than 660 endowment funds valued at approximately \$130M, we wisely invest the funds' assets and distribute approximately \$6M annually in scholarships and grants to support individual and nonprofit organizations in Lorain County.
